

Improvements include central air conditioning via a roof mounted unit and boiler heat supplied by a Crane model 10-400 gas. This location benefits from excellent visibility, dense residential surroundings, and close proximity to the Chicago Bears future stadium.

Located on Northwest Highway or Route 14, one of the primary corridors with a strong retail presence, this artery also connects the city of Crystal Lake to Chicago. With its close proximity to Arlington Heights Road, this location benefits from easy access to major thoroughfares, including I-90/I-290, Route 53 interchange, downtown Arlington Heights, the Union Pacific/Northwest line train station and O'Hare Airport.
